## **Building Permit Discussion – NOTES**

- Welcomed new Chief Building Official, Chris Meloche
- Transportation from island for CBO (applicant should pay?), boat and time
- Building Permit fees belong to the township
- Interim steps in the permitting can be fulfilled by photographs, final step for a dwelling requires an in-person CBO visit
- Soils reports are less stringent for seasonal dwellings
- Chris reported that there are five closed permits since 2019
- Status of buildings built without a permit. The township can require "as built" drawings
- Upper limit for non-permitted small buildings such as sheds, garages, bunkies etc is 108 sq ft for habitable and 162 sq ft for non-habitable
- Reviewed process starting with an application through to final approval (Lee offered to create a process-flowchart to assist ratepayers)
- CBO trips to island are weather dependent and at CBO discretion
- No weekend inspections
- Inspections May 15 to October 31 only
- Photographs accepted foe non-occupied buildings
